**Lecture Scenario:** In each of the following scenarios the student will:

- Identify if they are acting under the authority of an inspection or search.
- Identify authority to arrest, if appropriate.
- Identify any evidence to be seized and the authority.
- Articulate their actions in a report.

**Scenario #1:** Alcoholic Beverage Code Chapter - 101.04 Consent to Inspection

The officer and their partner are patrolling at 2345 near a bar that has been the source of frequent complaints from residents in the area. The complaints range from loud noise, intoxicated persons, fights, and drug use. The officer enters the bar with their partner to observe activities inside the bar and look for sources of the complaints. As they walk through the bar, they notice one of the bartenders acting extremely nervous and seeming to be trying to avoid their view. As they start to move behind the bar area, they see them quickly remove something from their pocket and drop it between some liquor bottles on a shelf under the bar. They check that area and find a small plastic baggie containing a white powdery substance.

**Scenario #2:** Alcoholic Beverage Code Chapter 101.03 - Search and Seizure

The officer is dispatched to an investigation regarding a complaint that someone is selling beer from their home. Upon arrival, the officer is approached by a neighbor who states they are the complainant. The complainant explains that the house in question has a lot of foot traffic coming and going at all hours. They further state they have seen people approach the house empty handed but leave carrying a case of beer. As the officer is speaking to the complainant the officer observes exactly what the complainant has described, someone approaching the house in question empty-handed and leaving with a case of beer. The officer approaches the house and knocks on the door, as it opens the officer observes multiple cases of beer stacked in the living room. The officer asks to step inside to speak to the occupant, but the occupants say they have nothing to say and close the door.

**Scenario #1:** Alcoholic Beverage Code Chapter 101.63 Sale to Certain Persons

The officer and their partner are patrolling at 2345 near a bar that has been the source of frequent complaints from residents in the area. The complaints range from loud noise, intoxicated persons, fights, and drug use. The officer enters the bar with their partner to observe activities inside the bar and look for sources of the complaints. As the officer enters, they immediately notice a person standing next to the bar showing obvious signs of intoxication. Before they can approach the intoxicated person, the officer sees the bartender hand the customer a freshly opened bottle of beer. The customer pays the bartender and walks away from the bar.

**Scenario #2:** Alcoholic Beverage Code Chapter 104.01 Lewd, Immoral, Indecent Conduct

The officer and their partner are patrolling at 2345 near a bar that has been the source of frequent complaints from residents in the area. The complaints range from loud noise, intoxicated persons, fights, and drug use. The officer enters the bar with their partner to observe activities inside the bar and look for sources of the complaints. As the officer enters the bar, they observe a person who is showing obvious signs of intoxication walking toward them. The officer stops the intoxicated person and confirms they are intoxicated in their contact. During this interview, the officer finds that the intoxicated person is an employee of the bar who just got off duty and “had a couple of drinks at the end of my day”.

**Scenario #3:** Alcoholic Beverage Code Chapter 106.02 Purchase of alcohol by a minor and 106.03 Sale to minors

The officer is working a late shift and stops by a local convenience store to get some coffee. As they enter the store, the officer sees what appears to be an underage person at the register purchasing some wine coolers. The officer waits outside and stops them as they exit the store and confirms that they are only 19 years old.

**Scenario #4:** Alcoholic Beverage Code Chapter 106.024 Attempt to Purchase Alcohol by Minor

The officer is working a late shift and stops by a local convenience store to get some coffee. As they enter the store, the officer sees what appears to be an underage person at the register purchasing some wine coolers. The person looks up and sees the officer. They quickly put their money away, leave the wine coolers on the counter and head to the door. The officer stops them and confirms they are 20 years old.

**Scenario #5:** Alcoholic Beverage Code Chapter 106.06 Purchase of alcohol for a minor; furnishing alcohol to a minor

The officer is dispatched to a loud party complaint. Upon arrival the officer is met at the door by a minor holding a beer in a clearly marked can. The minor states they are just here at a party and offers to get the homeowner. As the officer is waiting, they observe multiple persons who are obviously under the age of 21 in possession of and drinking alcoholic beverages. The homeowner comes to the door and is identified as the parent of the minor who first opened the door. The homeowner explains that they are having a party for their child and the child’s friends. They further state they are the only adult present. When the officer inquires about the alcoholic beverages, the homeowner states that they are hosting the party to keep the kids “safe”, so that they can be sure nothing bad will happen and “they are going to get alcohol anyway, so this is the safest way to do it.”

**16.5. List the legal hours of sale and/or consumption of alcoholic beverages as well as the penalty for violations.**

- Hours of Sale: Liquor- Alcoholic Beverage Code Chapter 105.01

- Hours of Sale and Consumption: Certain Events- Alcoholic Beverage Code Chapter 105.09

**16.6. Differentiate between criminal and administrative actions.**

The Texas Alcoholic Beverage Code can be applied both criminally (to an individual) or civilly, through administrative actions against a business. Since these are different actions, criminal and civil, double jeopardy does not apply, and the same event can result in both actions being taken. Generally, administrative actions result in the suspension or cancellation of a license or permit. In most cases, the offending business can pay a civil penalty (fine) based upon the number of days of suspension imposed. If a license or permit is cancelled, the licensee or permittee is generally prohibited from obtaining another license or permit for 2 years. The Texas Alcoholic Beverage Commission is the designated agency for filing administrative actions. To successfully prosecute an administrative case the TABC will need the following information:

- Dates/times
- Location to include permit or license number.
- Reason for being at licensed premise.
- Primary observation, nature of offense or violation observed.
- Standard for alcohol violations (criminal negligence)
- Identities of involved persons.
- Statements
- Evidence
- Arrest if made.
- Completion of reports
- Permittee listed on license.
- Licensee listed on license.

Upon receiving a report from a law enforcement agency, the TABC will begin a separate, parallel investigation, often in conjunction with the reporting agency to determine if administrative action can be taken. TABC will also conduct investigations into incidents involving death or serious bodily injury where intoxication was a contributing factor to determine the source of the alcoholic beverage and the legality of its sale or possession.

**Practical Scenario:** Using any of the scenarios above, have the student write a report with the details to allow TABC follow up with administrative action.
