TEXAS COMMISSION ON LAW ENFORCEMENT

Quarterly Meeting Minutes December 4, 2014

On Thursday, December 4, 2014, at 9:30 a.m., the quarterly meeting of the Texas Commission on Law Enforcement (TCOLE) was held at the J.J. Pickle Research Campus, The Commons Learning Center, 10100 Burnet Road, Bldg 137, Austin, Texas.

Commissioners attending were Sheriff Joel W. Richardson, Presiding Officer; Ms. Patt Scheckel-Hollingsworth, Assistant Presiding Officer; Ms. Patricia Garza; Major Jason Hester; Constable Ron Hood; Mr. Rob Kyker; Mr. James Oakley; Senior Police Officer Joe Pennington; and Chief Ruben Villegas.

Agenda item #1, Call to order.

Presiding Officer Richardson called the meeting to order. Sgt. Brian Wahlert, Officer Sean Quinn, Officer Thomas Garza, Officer Hanna Garrett, and Officer Scott Walker of the Caldwell County Sheriff's Office Color Guard presented the colors. Commissioner Hood led the pledge of allegiance and Commissioner Hester gave the invocation. Kaye Wilson called the roll and announced that all commissioners were present.

Agenda item #2, Reading of peace officer/jailer deaths since the September 2014 meeting.

Ken Mobley announced that there have been five officer deaths since the September meeting.

- *Senior Deputy Jessica Hollis, Travis County Sheriff's Office, EOW 9-18-2014*

Senior Deputy Jessica Hollis drowned after her patrol car washed away as she checked roadways for high water during a period of heavy rain. Deputy Hollis' body was recovered from Lake Austin on September 19th, 2014.

Deputy Hollis had served with the Travis County Sheriff's Office for seven years and was a member of the agency's Dive Team. She is survived by her husband and 12-year-old son. Deputy Hollis' husband serves with the Austin Police Department.

- *Sgt. Michael Joe "Mike" Naylor, Midland County Sheriff's Office, EOW 10-9-2014*

Sergeant Mike Naylor was shot and killed as he and other deputies served a warrant on a child sexual predator at a home. As Sergeant Naylor was negotiating with the individual, the man suddenly fired a shot, striking the officer. He was taken to Midland Memorial Hospital where he later succumbed to his wound.

Sergeant Naylor was assigned to the Mental Health Unit, and also served as the department's Honor Guard commander. He had previously served with the United States Air Force.

- *Deputy Sheriff Jesse Valdez, III, Harris County Sheriff's Office, EOW 10-29-2014*

Deputy Sheriff Jesse Valdez was killed when his patrol car was struck head-on by an SUV. He was responding to conduct a welfare check when the SUV crossed the center line and struck his patrol car head-on. Rescue crews extricated him from the vehicle and he was transported to Memorial Hermann Trauma Center where he succumbed to his injuries. It is believed the driver of the vehicle was under the influence of narcotics at the time of the crash. She had been paroled from prison only three weeks earlier while serving a two year sentence for a previous conviction of the same charge.

Deputy Valdez had served with the Harris County Sheriff's Office for 11 years. He is survived by his 10-year-old son and mother.

- *Constable Robert Parker White, El Paso County Pct 1, EOW 11-1-2014*

Constable Robert White was killed during an altercation with a subject while working an overtime assignment. Constable White was assaulted by a subject with which he was struggling. During the ensuing struggle Constable White was knocked to the ground and failed to get back up. He was transported to a local hospital where he was pronounced dead. Members of the El Paso County Sheriff's Office responded to assist Constable White and arrested the subject, who was subsequently charged with capital murder.

Constable White had served as the elected constable of El Paso County Precinct 1 for 18 years.

- *Sgt. Alejandro Martinez, Willacy County Sheriff's Office, EOW 11-21-2014*

Sergeant Alex Martinez was killed in a single vehicle crash south of Raymondville. His patrol vehicle overturned several times and came to rest in a nearby field. He suffered fatal injuries in the crash.

Sergeant Martinez had served with the Willacy County Sheriff's Office for 11 months. He had previously served with the Weslaco Police Department, Texas Department of Criminal Justice, and as the chief of the Raymondville Police Department.

Agenda item #4, Approval of the minutes of the September 4, 2014, quarterly commission meeting at Austin, Texas.

Commissioner Oakley made a motion to approve the minutes of the September 4, 2014 meeting. Commissioner Hester seconded the motion. The motion passed unanimously.

Agenda item #5, Receive Presiding Officer's Report. Take action, if necessary.

- Announce dates of the 2015 quarterly commission meetings.

Presiding Officer Richardson announced that the 2015 quarterly commission meetings will be held at the J.J. Pickle Center on March 5, June 11, September 10, and December 3.

Commissioner Patricia E. Garza from Olmito, Texas was introduced as the newest commissioner appointed by the Governor. Commissioner Garza is fulfilling the unexpired term of Commissioner Johnny Lovejoy. She graduated law school at Oklahoma City University and has served as an Assistant District Attorney. She is currently in private practice.

Commissioner Lovejoy served on the commission for several years and as the commission secretary, and the Presiding Officer wanted to publicly thank him for his service.

Agenda item #3, Election of Secretary.

The Presiding Officer opened the floor for nominations. Assistant Presiding Officer Hollingsworth nominated Commissioner Jason Hester. Commissioner Oakley seconded the nomination. There being no other nominations, the Presiding Officer declared Commissioner Hester secretary by acclamation.

Agenda item #6, Receive Executive Director's Report. Take action, if necessary.

Executive Director Vickers introduced new staff member, Gretchen Grigsby, Director of Government Relations. Ms. Grigsby comes to TCOLE from the office of Senator Craig Estes where she was the policy analyst responsible for making recommendations on homeland security, criminal justice, and transportation issues. In addition to her policy role, she served as clerk for the Senate Committee on Agriculture, Rural Affairs and Homeland Security, of which Senator Estes is chair.

She began working on law enforcement and homeland security issues in 2006 as a research analyst in the Governor's Office of Homeland Security, before transitioning with the homeland security team to the Texas Department of Public Safety. There, she worked as a legislative coordinator in the DPS Government Relations Office, where she worked closely with DPS management and legislative staff to monitor legislation and convey its impact to the agency.

Mr. Vickers reminded everyone that the deadline for submitting names for nominations of the Law Enforcement Achievement Awards is December 31. Applications are available on the TCOLE website.

Staff has received positive feedback from the 669 attendees of the annual training coordinators' conference. Attendees commented that they enjoyed the speakers, liked the general session format, and received helpful information during the TCOLE Q&A sessions. The next conference is October 19-22 in Corpus Christi. The Omni Bayfront Hotel is accepting reservations now. Commissioner Hollingsworth said that she attended the conference as a practitioner and received positive evaluations from other

attendees about the speakers and presentations. She commended staff for an outstanding job.

Commissioner Oakley made a motion to accept the Executive Director's report and Commissioner Kyker seconded the motion. The motion passed unanimously.

Agenda item #7, Receive reports, items to discuss, follow-up items from previous meeting. Take action, if necessary.

- Expedited waiver process proposal.

A request was made at the September 2014 meeting for the commission to consider a more expedited way to review and grant Class A and B waivers for telecommunicators. Mr. Vickers noted that staff has been involved in many discussions on this topic and feel strongly that three of the licenses issued by TCOLE, peace officer, jailer, and telecommunicator, are equally important and are critical parts of the criminal justice system. To single out one license to expedite the process is not feasible. Therefore, staff recommends that there not be a change to the waiver process. However, because staff was tasked to develop viable alternatives, handling the Class B waivers in office for the three licenses mentioned is a possibility. If the Executive Director denies a waiver, the agency could then appeal to the commissioners. Class A waiver requests would continue to go directly before the commission. Commissioner Hester asked if there is anything in rule that prevents staff from approving a temporary license. Mr. Beauchamp said that the commission can delegate to the executive director any of their functions which do not contradict statute.

Brian Hawthorne, Sheriff of Chambers County, approached the commission and stated that he was speaking on behalf of the Sheriff's Association of Texas. He is agreeable to the Executive Director taking on the responsibility of deciding whether or not a waiver should be approved. He asked the commission to keep an open mind on this matter.

Charles Hall, Constable, Midland County, reminded the commission that those coming before them with a Class B waiver request have committed a crime. Those agencies, as well as the individual, wanting a waiver should appear before the commission. He stated that the waiver process needs to remain as is.

Commissioner Hollingsworth made a motion to accept the Executive Director's proposal to leave the process as is. Commissioner Villescás seconded the motion. The motion passed unanimously.

Agenda item #8, Discuss and take action on proposed orders of amendments to existing TCOLE rules.

Mr. Beauchamp reminded the commission that the rules being voted on today are proposed, and will move on to public comment. They are not final rules.

- **Proposed Amendment 1**

§ 211.3(c)(2) Public Information (amendment)

This amendment removes the former web domain name from the rule.

Commissioner Oakley made a motion to approve the proposed amendment.

Commissioner Hood seconded the motion. The motion passed unanimously.

- **Proposed Amendment 2**

§ 221.43 Special Weapons and Tactics Proficiency Certificate (new)

This new rule provides for basic, intermediate, and advanced proficiency certificates for SWAT, requires specialized training, and requires certification from the chief administrator. The timeline is 2 years for expiration.

- **Proposed Amendment 3**

§ 221.45 School Resource Officer Proficiency Certificate (new)

This new proficiency certificate will require completion of an approved course, certification from the chief administrator, and recertification after 2 years.

- **Proposed Amendment 4**

§ 221.47 Canine Officer Proficiency Certificate (new)

This new proficiency certificate requires an approved training course with certification from the chief administrator and 2 year requalification.

Commissioner Oakley made a motion to approve amendments 2, 3, and 4. Commissioner Hood seconded the motion. Discussion followed. Commissioner Hollingsworth asked if there are any approved courses for the SWAT certificate and for the 240 hour requirement for the intermediate SWAT certificate. Mr. Vickers explained that the rule is the framework for the certificate and there will be addendums for

handling the details. Because it takes 6 months to make changes to a rule, the wording is usually not detailed. Course approval will be based on competency and skill sets. If these proposed rules are approved, they will move to the public comment area where requirements can be fine-tuned. Entities providing specialized training in these areas will submit their courses to TCOLE to be compared to the skill sets necessary for the proficiency. The 240 hour requirement can be tweaked to refer to 240 hours of SWAT training. Because we have received multiple requests from practitioners, we are bringing these proposed proficiency certificates forward. Commissioner Hollingsworth noted that this may open the door to other specialized certifications. Commissioner Garza shares Commissioner Hollingsworth's concerns that there should be no ambiguity if we expect licensees to meet these requirements. Commissioner Hester pointed out that although proficiency certificates are not required, the SFST proficiency was used against officers in court. Mr. Beauchamp noted that staff can reach out to the District and County Attorney's Association and the Texas Association of Counties for input on the liability issue. Training reported to TCOLE must come through a contract training provider which ensures the quality of the training or it can be in-house training approved by the agency administrator. Commissioner Hollingsworth asked if we have notified the associations about these proposed rule changes, and was assured that notices have been sent. Commissioner Hester suggested there be standing committees of subject matter experts to approve the courses as they are submitted. Director Helenberg replied that we have reached out to new associations for Canine and School Resource Officers. Commissioner Oakley suggested that if the associations want these proficiency certifications, we should start the process to allow for fine-tuning. Commissioner Pennington asked about the mechanics of the certifications. Should the officer change jobs, must a certificate approved at one agency be recognized by another agency? Should an officer receive another assignment within the same agency, does he maintain the certification? Mr. Vickers said there will not be a tracking mechanism. He reminded the commission that the certificate is valid for 2 years and must have the current agency administrator verify that the officer is still in the job assignment for which the certificate was issued.

Todd Radford, sitting Chief for the Lakeway Police Department and President of the Capital Area Law Enforcement Executives Association asked for clarification between licensure, certification of proficiency, and recognition of achievement. Would update courses or a letter of service from the chief executive be adequate? He is in favor of the development of the certificates and offered to be a part of the development process. Director Helenberg noted that this is not a license, nor is it a certificate. It is a certificate of proficiency that can be considered an award, you have reached a level of recognized

proficiency. Mr. Beauchamp stressed that this is a recognized proficiency as noted in 1701.402 which states that the “commission shall issue certificates that recognize proficiency based on law enforcement training, education, and experience.” The statute doesn’t say prove or establish proficiency. Commissioner Oakley asked Mr. Vickers if he had enough information from the discussion to go forward or should the motion be pulled down. Mr. Vickers suggested we go forward, using public comments to guide the final decision.

Mike Perry, Assistant Chief, Abilene Police Department, expressed concerns about the additional cost involved, liability concerns, past SFST problems in court, and clarification on the proposed rules.

There being a motion on the floor, Presiding Officer Richardson called for a vote. Commissioners Pennington, Garza, Hood, Oakley, Kyker, and Hester voted in favor with Commissioners Villegas and Hollingsworth voting against. The motion passed.

Agenda item # 9, Discussion of and take actions on proceedings for revocation, suspension, and other disciplinary actions.

Bassi, Juan G. Contreras, James D. Evans, Juan Hernandez, Kristoffer K. Lewis, Gary A. Mendez, Juan A. Montes, Santiago Montez, III, James W. Owens, Joshua J. Quinton, Antonio Sanchez, and Terrance D. Thomas. Commissioner Oakley seconded the motion. The motion passed unanimously.
