TEXAS COMMISSION ON LAW ENFORCEMENT

Quarterly Meeting Minutes June 8, 2017

On Thursday, June 8, 2017, at 9:30 a.m., the quarterly meeting of the Texas Commission on Law Enforcement (TCOLE) was held at the J.J. Pickle Research Campus, The Commons Learning Center, 10100 Burnet Road, Building 137, Austin, Texas.

Agenda item #1, Call to order

Presiding Officer Joel Richardson called the meeting to order at 9:30 a.m. The presentation of colors was by the Tarrant County Sheriff's Office Color Guard members Sergeant Robert Robeson, Charles Holland, Corporal Anson Tang, Officer Erik Kautz, and Officer Chantea Dixon. Commissioner Burruss led the pledge of allegiance and Commissioner Hester gave the invocation. Roll was called and all commissioners were present.

The Presiding Officer welcomed all to the meeting and introduced the new commissioners appointed by Governor Abbott and approved by the Senate: Chief Kim Lemaux of the University of Texas at Arlington Police Department; Ms. Sharon Breckenridge Thomas of San Antonio, Principal and Owner of the Breckenridge Thomas Law Office, and Senior Patrol Officer Tim Whitaker with the Houston Police Department.

Agenda item #2, Reading of peace officer/jailer deaths since the March 2, 2017, meeting.

Ken Mobley read the name of the line of duty death since the last commission meeting.

Assistant Chief Deputy Clinton Greenwood, Harris County Constable's Office, Pct. 3, EOW Monday, April 3, 2017

Assistant Chief Deputy Clint Greenwood was shot and killed behind the agency's headquarters building in Baytown. He was shot from ambush as he arrived for work and was flown to Memorial Hermann Hospital where he succumbed to his wounds. Assistant Chief Deputy Greenwood served in law enforcement for 30 years. He was previously with the Harris County Sheriff's Office, Harris County Pct. 4 Constable's Office, and the Harris County District Attorney's Office.

Agenda item #3, Approval of the minutes of the March 2, 2017, quarterly commission meeting at Austin, Texas.

Commissioner Hester made a motion to approve the minutes. Commissioner Oakley seconded the motion. The motion passed unanimously.

Agenda item #4, Receive reports. Take action if necessary.

- Presiding Officer's Report

The Presiding Officer invited all to attend the Law Enforcement Achievement Awards ceremony the following day at 10:00 a.m. at the Capitol Auditorium and the reception following that is hosted by TMPA.

The Audit Committee will meet on Wednesday prior to the September meeting at 3:00 p.m. with a report to be given by the Chair at the quarterly meeting.

Presiding Officer Richardson recognized the three commissioners whose terms have ended, and thanked them for their service: Mr. Rob Kyker of Addison, Houston Police Department Senior Police Officer Joe Pennington of Jersey Village, and Pharr Police Chief Ruben Villegas of Pharr.

- Executive Director's Report

Executive Director Vickers reported that Hemphill County Sheriff's Office has been approved as a contract training provider since the last quarterly meeting.

Tom Bickers has joined TCOLE as the field agent handling the I-20 corridor which includes West Texas and the Dallas Fort Worth area.

Commissioner Hester noted the "other personnel cost" line item in the budget was reaching the threshold. The Executive Director explained that most of this fund covers longevity, vacation, exit payouts, and retirement contributions. Shortfalls can be covered from other areas. Also noted was an increase in capital expenditures in March. Mr. Vickers noted that an increase like this usually occurs when there is a major purchase of IT equipment, in this case equipment to ensure the integrity and security of our network system. Commissioner Hester asked for an update on whether staff is seeing movement in training in underserved areas, especially West Texas. Mr. Vickers noted that the agency was prepared to help start an academy in the Fort Stockton area when Midland College offered to assist. Staff will be following up on the success of this. He also gave an update on the academic alternative providers stating that Austin Community College is working on cross walks between courses at different institutions and should present their final product soon.

- Operations Director's Report

Director Helenberg informed the commission of the number of peace officers, reserve officers, county jailers, and telecommunicators that need to complete their legislatively mandated training requirements by the end of this training cycle. Telephone calls to credentialing have increased significantly as we reach the end of the cycle. Next week, high ranking members of law enforcement in Mexico will be meeting in Austin to learn about Texas law enforcement. This is the third and final group that the State Department will be bringing for training. Director Helenberg listed some of the current active committees which include: Background Rules Committee, Basic Peace Officer Curriculum Update Committee with a draft due in August and implementation mid-year 2018, Jailer Curriculum Update Committee (mental health, de-escalation, and crisis

intervention hours are being extended in each of the above courses per legislative mandate), Supplemental Peace Officer Course Committee, School Marshal Curriculum Committee, and the State and Federal Law Update Committee.

- **Government Relations Director's Report**

Director Grigsby reported that there were 59 bills impacting TCOLE that were filed in the 85th regular session, but only 8 were passed. Four bills will require new training: HB 34, eyewitness ID training, SB 42, court security bill, SB 30, civilian interaction training, and SB 1849, the Sandra Bland Act requiring de-escalation training for members of the public and jailers. The agency sustained a 1.6% budget decrease over the biennium with no loss of staff positions or major programs. The special session will begin July 18.

Commissioner Burruss made a motion to accept all reports. Commissioner Hollingsworth seconded the motion. The motion passed unanimously.

Agenda item #5, Discuss and take action to approve the recommendations for the Law Enforcement Achievement Awards.

Commissioner Hollingsworth made a motion to approve the recommendations for the Law Enforcement Achievement Awards. Commissioners Oakley and Burruss seconded the motion. The motion passed unanimously.

Agenda item #6, Receive items of interest. Take action, if necessary.

- **Information concerning Course 4067, Commissioner Burruss**

Commissioner Burruss invited Erin McGann, Justice Involved Veterans Coordinator, Veterans Mental Health Program, Texas Veterans Commission and Sean Hanna, Senior Director of Veteran Engagement at the Meadows Mental Health Policy Institute to attend today's meeting. Ms. McGann spoke to the Commission about the free, 24 hour course developed through TCOLE that provides training for peace officers covering military culture, PTSD, traumatic brain injury, military sexual trauma and moral injury. She is available to help schedule training for police officers. It was suggested that Mrs. McGann possibly be able to conduct a presentation at the next training coordinators conference.

- **Accreditation issues**

Executive Director Vickers noted that commission rule 211.1 references regionally accredited institutions. TCOLE recognizes hours from regionally accredited colleges and universities toward training points. This rule does not intend to direct agencies what they will accept for college credit. The decision in the past to recognize regionally

accredited institutions is due to the in-depth accreditation process that these colleges are required to complete. Occasionally requests are received asking TCOLE to reexamine the rule. Commissioners Hollingsworth and Hester voiced their support to continue awarding training credit for college hours completed at regionally accredited institutions. There was no motion on this agenda item. The Presiding Officer directed the agency to continue the current practice.

Agenda item #7, Discuss and take action on the Request for Waiver of TCOLE Rule 217.1 Minimum Standards for Enrollment and Initial Licensure

- Hutchinson County Sheriff's Office for Dianna F. Asbury
Sheriff Kirk A. Coker addressed the Commissioners requesting a waiver on behalf of Dianna Asbury, a jailer with the sheriff's office. Ms. Asbury was also present and addressed the Commissioners.

Commissioner Oakley made a motion to approve the waiver. Commissioner Hood seconded the motion. Commissioner Hester asked for clarification that this is for a jailer license. The motion passed unanimously.

- Harris County Constable's Office, Precinct 4 for Colby Romero
Constable Mark Herman spoke on behalf of Pct. 4 Constable's Office asking that the Commissioners grant a waiver to allow them to hire Colby Romero. Mr. Romero addressed the Commissioners and answered questions.

Commissioner Hood made a motion to approve the waiver. Commissioner Oakley seconded the motion. The motion passed unanimously.

- Carrollton Police Department for Jovam Villegas
Carrollton Police Chief Rex Redden requested a waiver for Jovam Villegas. Mr. Villegas was present and answered questions posed by the Commissioners.

Commissioner Oakley made a motion to approve the waiver request. Commissioner Thomas seconded the motion. The motion passed with Commissioner Hollingsworth abstaining.

Agenda item #8, Discussion of and take actions on proceedings for revocation, suspension, and other disciplinary actions.

Mr. Winter addressed the Commission, reviewing the disciplinary actions.
