# Bexar County Constable PCT 3

Precinct 3 Deputy Constables have county wide jurisdiction for criminal law enforcement. Precinct 3 is approximately 284 square miles and covers the north side of Bexar County. Constables work in a proactive environment encompassing felony/misdemeanor warrants, traffic, and related law enforcement issues. Constables also conduct warrant arrests and serve court documents. Enclosed is our hiring process along with Bexar County benefits and Constable benefits. There are two QR codes, one for Bexar County benefits showing the cost breakdown for medical and another one is for our application. ## **Hiring Full Time Law Enforcement Deputy Constable**

Pay Rate: First year \$57,540 annual / \$4795 Monthly up to \$87,924 annual / \$7,327 monthly

The Constable's Office has many opportunities in law enforcement to include, traffic, commercial motor vehicle enforcement (weight enforcement), school resource officers (Comal ISD schools within Bexar County), Bailiff and Court Security for Justice Court, executing warrants, and proactive law enforcement. Traffic motor officer positions open, if qualified.

- Complete Bexar County Constable Pct 3 Personal History Statement and Polygraph packet, emailed to you
- Oral Interview Board
- Background; will work with applicant in relation to current employer and when to contact
- Polygraph, here at Pct 3 with the Constable
- Conditional Job Offer
- Drug Screening & Physical, Psychological if necessary, and DPS fingerprinting

### **Job Duties**

- Operate emergency vehicles while patrolling specific areas to detect law violators, issue citations, and make arrests. Investigate illegal or suspicious activities
- Execute arrest warrants, locating and taking persons into custody
- Record daily activities, and submit logs and other related reports and paperwork to appropriate authorities
- Patrol and guard Justice Court, Jury rooms, schools, and assigned areas
- Place people under emergency detention
- Take control of accident scenes to maintain traffic flow, to assist accident victims, and to investigate
  causes
- Serve, subpoenas, citations, writs, Texas Attorney General child support orders, and other court orders
- Respond to citizens calls involving vehicle accidents, crimes, neighborhood disturbances, fire and other citizen requests, obtain witness statements, and photograph crime scenes
- Issues citations, serve warrants of arrest, apprehend suspects and arrest persons charged with felonies and misdemeanors, provide courtroom testimony
- Performs other duties as assigned

## **Minimum Qualifications**

- High School or General Education Development (GED) certificate
- Minimum Basic Peace Officer Certificate from the Texas Commission on Law Enforcement (TCOLE)
- Must be currently employed as a full-time peace officer for last six months, exceptions on case-by-case basis or successful completion from law enforcement academy seeking first law enforcement position
- Must have no prior convictions for: driving while intoxicated, driving while impaired, no possession or trafficking of illegal narcotics or drugs, assault, stalking, family violence, theft, crimes of moral turpitude, or sexual offenses
- Military applicants must disclose any non-judicial discipline involving the Uniform Code of Military Justice
- Must have never been on court-ordered community supervision or probation for any criminal offense
- Must not be currently under indictment for any criminal offense
- Good knowledge of Federal, State and Local laws, codes and statutes
- Must be able to patrol assigned district attempting to detect and suppress criminal activity
- Must be able to make criminal justice inquiries on suspects to determine if wanted and making arrest when appropriate
- Must be able to prepare detailed incident reports
- Must be able to enforce traffic laws by patrolling and issuing traffic citations to violators
- Investigate traffic accidents
- Must be able to testify in court
- Ability to effectively respond to citizen inquires and complaints
- Skill in communicating effectively both in writing and in person utilizing the English language
- Ability to maintain effective working relationships with coworkers, Elected/Appointed Officials, Department/Division Heads, County employees, government agencies and the general public
- Must secure and maintain a favorable background investigation from the Bexar County Constable's Office Pct 3
- May be required to work during daylight hours, evenings, and occasional overnight and work more than 40 hours during a workweek



QR link to application, scroll to find Deputy Constable-Precinct 3 and click on and then click Apply. You will need to create an account and then fill out and submit the application.

Background investigators work with applicants who have concerns with their current law enforcement employer being contacted at the beginning of the process. TCOLE Secure-Share can be done at the latest stage of the background investigation if needed or after a conditional job offer has been made.
